



HOME OCCUPATION BUSINESSES

To promote business opportunities, the City of Arcata has adopted standards for “Home Occupation” businesses. These standards allow many types of businesses to operate out of a residence. At the same time, the standards protect neighbors from business traffic and business activities that aren’t compatible with residential neighborhoods.

If you will operate your business from your home, the Home Occupation Affidavit needs to be completed and submitted to the Community Development Department – usually at the same time your Business License application is submitted. It is reviewed by a City Planner to ensure the business is allowed in a residential neighborhood.

Types of Allowed Business Operations

This list shows the types of businesses already determined to be appropriate for home business operations, but is not a complete list. The Director of Community Development may approve business types not on this list.

- ▶ Artist studios – ceramics, painting, photography, sculpture, and similar activities
- ▶ Tailoring and sewing operations
- ▶ Businesses with small offices: architects, attorneys, consultants, counselors, insurance agents, e-commerce, tutors, writers, and other similar occupations
- ▶ Personal trainers, and licensed massage and physical therapists

Limitations to Business Operations

- ▶ The business must be clearly secondary to the residence – the property must look like a residence
- ▶ Business activity may not be visible – no window displays are allowed
- ▶ Signs must be 2 square feet or less and attached flush to a wall
- ▶ Only standard household hazardous materials are allowed
- ▶ Materials and equipment may not be stored outside
- ▶ Only full-time residents of the home may be employees of the business
- ▶ Operating hours must be between 9 am and 5 pm, with limited customer traffic and only typical delivery services
- ▶ Electric and gas utilities may not be modified to accommodate the home business

Types of Operations Not Allowed

- ◀ Operations that cause dust, glare, heat, noise, odors, smoke, excessive traffic, or vibration
- ◀ Those using explosives, hazardous, toxic, or highly combustible materials
- ◀ Vehicle repair shops, storage yards, machine shops, wood-cutting, and welding operations
- ◀ Animal hospitals or boarding facilities, medical clinics and labs, and sex-oriented businesses

Please note that this is a *summary* of Home Occupation Businesses standards – the City’s Land Use Code regarding home occupation standards and requirements is included with this informational sheet.
