

ORDINANCE NO. 1529

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ARCATA AMENDING ARTICLE 9 (STOPPING, STANDING AND PARKING) AND ARTICLE 11 (STOPPING, STANDING OR PARKING RESTRICTED OR PROHIBITED ON CERTAIN STREETS) OF CHAPTER 2 (TRAFFIC REGULATION), TITLE III (PUBLIC SAFETY) OF THE ARCATA MUNICIPAL CODE TO REVISE TIMED PARKING AND PARKING METER ZONE REGULATIONS

The City Council of the City of Arcata does ordain as follows:

Section 1: Sections 3508 and 3512 of Title III (Public Safety), Chapter 2 (*Traffic Regulation*), Article 9 (*Stopping, Standing and Parking*) are hereby amended as shown in the following strike through for deleted text and double underscore for new text:

SEC. 3508 ~~Parking time limited on certain enumerated streets (4 hour parking).~~ Limited Time Parking.

~~When authorized signs are in place giving notice thereof, no person shall stop, stand or park any vehicle on any of the streets enumerated by resolution of the City Council for a period of time longer than four (4) hours at any time between the hours of 9:00 a.m. and 6:00 p.m. of any day except Sundays and holidays. The City Council may by resolution prohibit or restrict the stopping, parking, or standing of vehicles, including but not limited to vehicles that are six feet or more in height, within 100 feet of any intersection, on certain streets or highways, and on any City-owned off street parking facility, or portions thereof, during specified hours of the day. Such prohibitions or restrictions made through resolution shall not apply until signs or markings giving adequate notice thereof have been placed, and when such notice has been placed, stopping, standing or parking any vehicle in violation of the prohibitions or restrictions as set for the in the resolution shall be prohibited.~~

SEC. 3512 Parking Meter Zones.

~~Parking meter zones shall be established within boundaries that coincide with the designated preferential parking zones. Within the parking meter zones, streets where parking is permitted at parking meters shall be designated by a resolution by the City Council. The rate of fee for parking within a parking meter zone shall be as set forth in the Schedule of Fees adopted by resolution of the City Council. Parking meter zones are those streets or portions of streets in the City hereinafter described as zones within which the parking of motor vehicles shall be controlled, regulated, and inspected with the aid of parking meters and/or pay-and-display stations. Parking meter zones are hereby designated as follows:~~

<u>13th Street:</u>	<u>B Street to C Street, north side</u>
<u>14th Street:</u>	<u>L.K. Wood Boulevard to Union Street, (north side)</u> <u>L.K. Wood Boulevard to B Street (south side)</u>
<u>17th Street:</u>	<u>Union Street to 150 feet east, north side</u>
<u>B Street:</u>	<u>13th Street to 14th Street, west side</u>

C Street: 13th Street to 14th Street, east side
Granite Ave.: L.K. Wood Boulevard to 500 feet east (south side)
Union Street: 150' south of 16th Street to 17th Street, west side only;
 17th Street to 18th Street, east and west side

Section 3: Sections 3509 and 3513 of Title III (*Public Safety*), Chapter 2 (*Traffic Regulation*), Article 9 (*Stopping, Standing and Parking*) are hereby repealed.

~~SEC. 3509 Parking time limited in off-street parking lots (4 hour parking).~~

~~When authorized signs are in place giving notice thereof, no person shall stop, stand or park any vehicle in any off street lots enumerated by resolution of the City Council for a period of time longer than four (4) hours at any time between the hours of 9:00 a.m. and 6:00 p.m. of any day except Sundays and holidays.~~

~~SEC. 3513 Parking Time Limited on Certain Enumerated Streets (Four Hour Parking Within Designated Preferential Parking Areas)~~

~~When authorized signs are in place giving notice thereof, no person shall stop, stand or park any vehicle on any of the streets within any preferential parking zone, as enumerated by resolution of the City Council, for a period of time longer than four (4) hours at any time between the hours of 7:00 a.m. and 5:00 p.m. any day except Saturday, Sunday and holidays; and when Humboldt State University is not in session.~~

Section 2: Sections 3513 and 3514 are hereby added to Title III (*Public Safety*), Chapter 2 (*Traffic Regulation*), Article 9 (*Stopping, Standing and Parking*), as follows:

SEC. 3513. Time of Operation of Parking Meters

The provisions of this chapter relating to the operation of parking meters shall be effective between the hours of 7:00 am and 5:00 pm Monday through Friday.

SEC. 3514. Parking Meter Fees

The cost for parking any vehicle, except those displaying a valid disabled person insignia or City of Arcata Zero Emissions permit, shall be seventy-five cents (\$0.75) per hour during the time of operations.

Section 3: Section 3554 of Title III (*Public Safety*), Chapter 2 (*Traffic Regulation*), Article 11 (*Stopping, Standing or Parking Restricted or Prohibited on Certain Streets*), is hereby amended as shown in the following strike through for deleted text and double underscore for new text:

SEC. 3554 Authority to Collect Fines (Ord. 1166, eff. 8/31/1990)

The Arcata Police Department is authorized to receive the payment of parking fines. In the event the Police Department is not successful in accomplishing payment, the citation shall be turned over to ~~the North Humboldt Judicial District, Arcata Branch, to be prosecuted through the judicial system~~ the California Department of Motor Vehicles or other state licensing authority

and a Department of Motor Vehicles registration hold will be requested.

Section 4: Sections 3546 and 3547 of Title III (*Public Safety*), Chapter 2 (*Traffic Regulation*), Article 11 (*Stopping, Standing or Parking Restricted or Prohibited on Certain Streets*) are hereby repealed.

~~SEC. 3546 Parking time limited on certain enumerated streets (2 hour parking).~~

~~When authorized signs are in place giving notice thereof, no person shall stop, stand or park any vehicle on any of the streets enumerated by resolution of the City Council for a period of time longer than two (2) hours at any time between the hours of 9:00 a.m. and 6:00 p.m. of any day except Sundays and holidays.~~

~~SEC. 3547 Parking time limited in off-street parking lots (2 hour parking).~~

~~When authorized signs are in place giving notice thereof, no person shall stop, stand or park any vehicle in any off-street lots enumerated by resolution of the City Council for a period of time longer than two (2) hours at any time between the hours of 9:00 a.m. and 6:00 p.m. of any day except Sundays and holidays.~~

Section 5: Severability. If any section, subsection, sentence, clause or phrase of this chapter is for any reason held to be invalid or unconstitutional, the decision shall not affect the validity of the remaining portions of the Chapter. The City Council hereby declares that it would have passed this Chapter, and each section, subsection, sentence, clause and phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases be declared invalid under law.

Section 6: Environmental Review. This Ordinance is exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15061(b)(3) of the CEQA Guidelines, because it makes minor and non-substantive revisions to clarify and update existing laws and practices, and does not alter any existing regulation or its implementation, or create new regulations or programs. There is no possibility that the revisions herein may have a significant effect on the environment.

Section 7: This ordinance will take effect thirty (30) days after the date of its adoption.
